### **Official Rules & Regulations**

**SMART Technologies: Reinvent Learning** 

#### **Contest Period:**

The SMART Technologies UK "WIN a SMART Board for your School" competition will begin on Monday,26<sup>th</sup> March 2018 at 12:00 noon GMT, and will run until Thursday, 31<sup>st</sup> May 2018 at 5:00 pm GMT.

## **Eligibility:**

Contest is open to all legal residents of Scotland, except where otherwise prohibited or restricted by law, who have reached the age of majority in their place of residence at the time of entry. Employees, contractors, representatives or agents (and those with whom such persons are domiciled, whether related or not) of the Marketing and Sales departments of SMART Technologies UK (the "Sponsor"), its dealerships, resellers, advertising/promotion agencies collectively, the "Contest Parties"), and their immediate family members (spouse, parent, child, sibling their respective spouses, regardless of where they reside) are not eligible to participate.

By participating in this Contest, you agree to be legally bound by the terms and conditions of these Official Rules and Regulations (the "Rules").

#### **How to Enter:**

No purchase necessary. Entries will be taken via digital forms on the contest landing page. Entry information taken shall include First Name, Last Name, E-mail Address, name of School to which the prize will be given and video story. The video story submitted should not be longer than 100 megabytes. The recommended format is .avi. Entries should only be submitted in English. Any minors mentioned in the written entries may do so only if parental or guardian permission has been explicitly obtained by the school and/or the entrant; any entries failing to meet this requirement will be disqualified from participation.

All entries will be evaluated by a panel of SMART staff members. This panel shall select the three winners, based on originality, impact, usability, and creativity of technology in the classroom.

All winners shall be chosen on or before 11<sup>th</sup> June 2018. Winners shall be contacted via the email address provided on the form by 5:00 pm GMT on 11<sup>th</sup> June 2018. Winners will be publicly announced following contact with SMART and confirmation of identity.

## **Prize and Approximate Retail Value:**

There will be three prize winners selected. The first prize shall be a SMART Board 7275 65" 4K panel and a KAPP 42. The estimated MSRP for the selected board will be approximately £5,799.

The second prize will be a SMART Board 6265 65" 4K panel and a KAPP 42. The estimated MSRP for the selected board will be approximately £3,749 and the estimated MSRP for the KAPP 42 panel will be approximately £599

The third prize will be two SMART KAPP 42. The estimated MSRP for the KAPP 42 will be approximately £599.

Prizes must be accepted as awarded with no substitutions except by the Sponsor in its sole discretion. Prizes are not transferable.

In the event that the prize is not available, for whatever reason, the Contest Sponsor reserves the right to substitute one of equal or greater value. Prizes will only be awarded to the person whose full name and valid email address appear on the official Contest entry form. The Prize will be delivered to the school designated by the winner on their entry form.

The odds of winning depend on the number of eligible Entries received in accordance with these Rules during the Contest Period.

The Sponsor or its designated representative will make five (5) attempts to contact the selected entrant via email or phone within ten (10) business days of the 11<sup>th</sup> June, 2018. If the selected entrant cannot be contacted within five (5) attempts or ten (10) business days of the Draw Date (whichever occurs first), or there is a return of any notification as undeliverable, then that selected entrant will be disqualified and the Sponsor reserves the right, in its sole discretion, to select an alternate eligible entrant from among the remaining eligible Entries.
